## General Goals:

This course covering party systems development in new democracies (specifically the Visegrad countries – Poland, Hungary, Czech Rep., Slovakia) will introduce 4th year political science students to the theory of party system analysis (comparative approach) in order to explain the practical outcome of the process of consolidation and overall development of the party systems of the V4 countries. In a short time period (by historical standards) the V4 countries covered a remarkable distance, transforming from satellite countries of the USSR to equal member within the EU and NATO. So, what does their way look like in terms of party systems development?

The course will assist students in developing familiarity with party systems analysis, general analytical skills, and familiarize them with contemporary relevant parties in the V4 countries. The course consist of 7 weeks (16 h of classes + 8 h of self-preparing time + research paper)

## Students course requirements:

Students speaking one of the V4 languages are encouraged to join the course, although the main research and literature is available in basic European languages (English, German). Students are expected to be prepared for each class session, to contribute to group discussion (and allow others to do the same), and to conduct independent research in from of a research paper (up to 15 p.).

**Format:** The course brings together a group of 4<sup>th</sup>-year students of the Political Science department who are interested in comparative politics, the Central and Eastern European transition story, party evolution and political institutions. The group is expected to discuss selected texts on theoretical approaches to party systems analysis, applying them to the process of development of the V4 party systems. Each student will have an opportunity to present their own research covering certain (TBA) aspects of the party systems development in the V4 countries as well as approaching case-studies of concrete parties and elections, which are relevant to the general process of consolidation.
